Godfrey stays on

course to get his revenge

Believe it or not, he gets shot at Ripley in final

Long-time Ann Arbor native Bill Godfrey had a new fan in attendance for Saturday's semifinals of the Ann Arbor City Closed Tennis Tournament.

Peter William Godfrey, born Wednesday evening, was at Burns Park to root his father on to a 3-6, 7-5, 6-3 victory over Marty Maehr in a men's AA match.

The elder Godfrey, the tournament's second seed who will play defending champ Paul Ripley in today's final, needed all the support he could get.

Godfrey, a Big Ten champion in No. 4 singles at Michigan in 1982 known for an extremely hard serve, won the seventh game of the third set after being down love-40 to take a 4-3 lead.

"All of a sudden I had a complete letdown," Godfrey said. "At that point I did a 30-second pause and went back to basics. After I won that game, I felt there was a big swing in confidence."
Ripley had little problems in his semi-

final, beating Laurent Leclerc 6-0, 6-2.

"I expected a lot tougher match," Ripley said. "He gave me a lot of free points in the beginning. That built up my confidence and I just kept going from there."

Today's final between Ripley and Godfrey, scheduled for 11:30 a.m. at Burns Park, promises to be a good one. Ripley, a 1991 Pioneer graduate and former state champion, defeated Godfrey in a three-set semifinal last year.

"I know he's really going to be out to get the one back," Ripley said. "It should be a good match and I'm looking forward

WOMEN'S AA SINGLES: Betsy Mehaffie and Kathy VanDeWege had a long day on the courts Saturday and may be in for a longer outing today.
