Ex-Pioneer star comes home for tourney

The former Pioneer High School standout and rising sophomore at Northwestern University is making his city tournament debut after playing No. 6 singles and No. 2 doubles for the Wildcats last season as a freshman.

Used to facing opponents his age who employ power shot strategies, Seyferth has had to adjust to more

seasoned, crafty opponents this weekend. He'll face Petreca in today's semifinals at 10:30 a.m.

Seyferth, who is the No. 3 seed, doesn't concern himself with who he faces or what style of match he'll be forced to play, focused instead on the final result.

"I want to win, and so you've got to beat everybody

to win the tournament." Sevferth said after beating Sorin Teodoro 6-2, 6-1 in Saturday's quarterfinals. "I'm just taking one match at a time, and I'll figure out my next opponent when I play them."
